





FIGURE 1. Physical dimensions 1N4565A-1 through 1N4584A-1 (DO-7 and DO-35).









The 340-hour reading shall be compared with the 0-hour reading and the 1,000-hour reading compared with the 340-hour reading. The change in breakdown voltage shall not exceed the limits specified. The test temperature for breakdown voltage shall be the same as the specified ambient life test temperature (see table IV herein).
- 4.5.3 <u>Reference voltage</u>. The test current shall be applied until thermal equilibrium is attained (15 s maximum) prior to reading the reference voltage. The attention of the contractors is called to these requirements, and manufacturers are urged to arrange to have the products that they propose to offer to the Federal Government tested for qualification in order that they may be eligible to be awarded contracts or orders for the products covered by this specification.
